#### FINANCIAL AWARENESS, ASSISTANCE AND EMERGENCY PREPAREDNESS EXPO 2009

Maryland residents need to know how to manage their finances, what to do in case of a foreclosure and how to prepare for natural disasters. A foreclosure means you could lose your home. Receiving notice that your house is about to be foreclosed upon is one of the most traumatic events you can experience. According to a report released by the Mortgage Bankers Association, a record 1.2 million homes were in foreclosure during the last three months of 2008. Also, the need to prepare for natural disasters is real. According to the Federal Emergency Management Agency, being prepared for a natural disaster can reduce your fear, anxiety, and losses.

The Maryland State Bar Association's Leadership Academy will present "*Securing Your Future Expo*" on **May 2, 2009**, at the University of Maryland Samuel Riggs Alumni Center from **10 a.m. to 5 p.m.** This Free Expo will equip attendees with the tools necessary to address issues such as: foreclosure, debt management and household budgeting, emergency preparedness and disaster relief.

As part of the Expo, volunteer attorneys from the Pro Bono Resource Center of Maryland will present a Foreclosure Solutions Workshop, where participants can get free one-on-one legal advice about their individual problems by lawyers who are trained in foreclosure prevention.
